Item 9: Other Matters

In relation to the application of Aboitiz Equity Ventures Inc. for the shelf registration of its proposed fixed rate bonds in the aggregate principal amount of Php30 billion (the "Bonds"), the Philippine Ratings Services Corporation ("PhilRatings") assigned an issue credit rating of "PRS Aaa" with a Stable Outlook to first tranche of the Bonds, equivalent to Php3,000,000,000 with an oversubscription option of up to Php2,000,000,000.

According to PhilRatings, obligations rated "PRS Aaa" are of the highest quality with minimal credit risk, an indication of the extremely strong capacity of the obligor to meet its financial commitment on the obligation. A Stable Outlook is defined as "The rating is likely to be maintained or to remain unchanged in the next 12 months." The rating and outlook were assigned based on the following key considerations: (i) AEV's highly experienced management team; (ii) the company's sustainable profitability and liquidity;

and (iii) its continuously growing asset and investment portfolio, supported by conservative leveraging.
