Background/Description of the Disclosure

On 5 January 2024, and pursuant to the regular cash dividend declaration of Megawide Construction Corporation (the "Company") for its Series 4 Preferred Shares (MWP4) with a payment date of 29 January of each year, the Company's Board of Directors ("Board") has set 22 January 2024 as the record date and 29 January 2024 as the payment date.
