

On 13 March 2024, and pursuant to the regular cash dividend declaration of Megawide Construction Corporation (the "Company") for its Series 5 Preferred Shares (MWP5) with a payment date of 17 April of each year, the Company's Board of Directors ("Board") has set 2 April 2024 as the record date and 17 April 2024 as the payment date.

The cash dividend is equal to PhP1.97605 per share, or a total of PhP29,640,750.00, out of the unrestricted retained earnings of the Company as of 31 December 2023.
