Gentlemen:

We advise that in its meeting today, our Board of Directors approved the declaration of the cash dividend for holders of its voting preferred shares payable on December 3, 2020 to shareholders on record as of November 17, 2020.

The amount of the cash dividend is based on the 2019 Benchmark rate of the 3-day average of the 5-year BVAL* (i.e. average of October 24, 25, 28, 2019) plus 2%. The aggregate dividend payment for the voting preferred shares is about ₱50.0 million.
