



**Globe Telecom closes term loan with
Land Bank of the Philippines**

Globe Telecom, Inc. signed a loan facility with Land Bank of the Philippines for Php5 Billion. The loan shall be used to finance the Company's general financing and corporate requirements for capital expenditures.

Globe spent Php33.4 Billion for capital expenditures as of end-September 2020, 81% of which was spent on data-related requirements.
