Please be informed that today, Mitsubishi Corporation ("MC") sold a portion of its holdings in Ayala Corporation ("Ayala") equivalent to 8,644,785 common shares at a price of PHP634 per share.

The sale of Ayala shares is a part of MC's strategy of portfolio management and fulfills MC's mandate to rebalance its assets.

Currently MC has no concrete plans to sell further holdings in Ayala.

MC highly values its nearly 50 years of partnership with Ayala and continues to place great importance on the relationship.

MC remain confident in the value that the Ayala investments brings to its portfolio. The partnership with Ayala continues to be a significant pillar in the region for MC, and we will continue to expand our collaboration with them in various new and existing sectors and projects well into the future.




