Please be informed that the Board of Directors of Union Bank of the Philippines ("Bank") at its meeting held on January 26, 2024, approved the following matters:

- Capital raising of up to Php10.0 billion via a stock rights offering ("SRO") to all existing stockholders, subject to regulatory approvals. Net proceeds will be used to fund the capital infusion to UnionDigital, projected retail loan availments, and/or for general corporate purposes.
- 2. Declaration of a cash dividend of Php0.80 per common share in favor of all stockholders of the Bank, payable from the available unrestricted retained earnings of the Bank as of December 31, 2023. The record date for stockholders entitled to the cash dividend is February 13, 2024, and payment date is set on February 20, 2024.
- 3. Amendment of Charter of the Related Party Transaction Committee to increase the number of members from three (3) to five (5).
- Appointment of Independent Director Josiah L. Go and Independent Director Honorio G. Poblador IV as additional members of the Related Party Transaction Committee, effective immediately.
